COVID-19 – CHALLENGES, VACCINATION AND MYTHS

Currently, Pakistan ranked among top three countries in Asia with high risk of COVID cases/patients and on the other hand it has one of the lowest numbers of people who were vaccinated. According to Our World In Data's dataset, Pakistan had administered only 1.8 vaccine per 100 people as of May 15. The Government policy of lock downs, especially on EID has helped bring down in the interim period positivity pan Pakistan barring few regions where the positivity is still high. The present super spreader events such as rallies and religious gatherings might further reignite the positivity rates. As the rate of the vaccination is still not fast enough for the overall coverage to go up in higher percentage this is the foremost important strategy. Till Pakistan gains high vaccination rates of COVID19 we will be vulnerable to more rise intermittently with chances of increase in death rates especially with the Indian variant of covid19 now being at global level a variant of concern and spread to many countries. Also, government has decided to open schools and universities which might gradually inch upwards the positive spread. One effective strategy could be to make it mandatory for teachers to be vaccinated prior to opening up fully and also students above 18 years of age as a priority. The common concern and its very surprising even educated peoples are showing some reservations for vaccination. So a comprehensive and a vigorous awareness drive shall be run across Pakistan to have maximum people vaccinated. There are certain

myths attached to COVID -19 Vaccines, and unfortunately it is spreading very fast and countries like Pakistan can face a big challenge in near future. Secondly, there are certain incidents or misreporting in different countries that resulted in some kind of confusion among people for the choice of vaccine. Some prefer Russian over UK and some prefer Chinese.It is recommended that everyone should go for vaccine (any vaccine). Except few patients who went through a surgery or on medical treatment. They are requested to consult their Doctor. Also, it's better to know if your body has responded to Vaccination against COVID19 vs expecting all is good! So I would recommend Spike protein antibody tests. Many people don't get protection and might be misled. The only solution to the given situation is Mass vaccination and we all need to join hands to meet the target of 4 crore people by the end of this year. With current pace of vaccination, this is very difficult but not an impossible task. However, only Strict SOPS Masks Social Distance and smart lock down policy be adopted, this will lower the spread. Pakistan has less congestion in cities as compare to India.

On the occasion, Nasir Mirza said that Rawalpindi Chamber of Commerce has also signed MoUs with various hospitals for the convenience of its members so that they can get quality health care and treatment facilities at affordable rates.

CEO TDC Tahir Abbasi said that the number of diabetics in Pakistan is increasing rapidly. Medical camps will also be conducted in collaboration with the Chamber of Commerce to raise awareness about diabetes.

TDC is Pakistan's first specialized diabetes hospital that provides medical care for diabetes and its all complications under one roof.-

RCCI urges for extended business hour to lower Covid threat

The Rawalpindi Chamber of Commerce and Industry (RCCI) President Mohammad Nasir Mirza has said that lockdown policy should be formulated in collaboration with stakeholders. The proposed lockdown from May 8 to May 16 is not feasible. The business community has been the hardest hit by the corona, he said in a statement. We have to make policy based on the ground realities. The working hours of banks and post offices should also be increased to provide convenience to customers and pensioners.

We recommend that shop hours be made to 24 hours during Ramadan so that customers can shop comfortably. Weekly off for Businesses should also be called off, he

suggested. Exporters will face more difficulty and demurrage charges added as the port will be closed for eight days. Reduced working hours will increase the rush in the markets and banks.

Former president and Group leader Sohail Altaf said that our Corona policy is not clear. It is based on trial and error. Every year there is more business on Eid. He said that like the rest of the world, we also have to run business along with Covid-19. The risk of Corona cases has increased due to the increase in rush. Vaccination should be increased along with strict implementation of SOPs, masks and social distance. The traders mainly from SMEs are in deep trouble due to lock-down.

RCCI welcomes inquiry report on Ring Road and urges for early completion of project


The Rawalpindi Chamber of Commerce and Industry (RCCI) has welcomed the completion of the inquiry report of the Rawalpindi Ring Road project and alleged cost increase and changes in the plan. In a statement, President RCCI Nasir Mirza said, "We demand that immediate action be taken against the elements for whom these alleged changes have been made and that those involved be brought to justice and that the project not be further delayed."

Referring to the press conference of SAPM to CM Punjab, Ms Firdous Ashiq Awan, he said, "We are happy that the Prime Minister has taken a personal interest in this matter and we hope that the project will be completed during his tenure." He said that if the Chamber of Commerce and the business community had already been kept on board and involved in the process, the project

would not have faced this situation.

He said that the business community believes that the Ring Road project will be a game changer for Rawalpindi. It is an important project for the development of Rawalpindi and it should be completed as soon as possible.

He suggested that a committee be formed on the platform of Rawalpindi Chamber of Commerce to liaise with the Rawalpindi Development Authority (RDA) and the Commissioner's Office and implement the suggestions of the stakeholders to remove the obstacles in the completion of the project. He said that the main objective of the project is to create new industry, relocation of markets, solve traffic problems and promote cottage industry.



RCCI Inks MOU With LADIES LOUNGE to Create Opportunities for Women Entrepreneurs



A memorandum of understanding (MoU) was signed between the Rawalpindi Chamber of Commerce & Industry (RCCI) and the Ladies Lounge aiming to create opportunities for women entrepreneurs. Subject: INTRODUCTION OF AMNESTY SCHEME

Dear Mirza Sb,

I hope that this letter finds you in the best of your health and spirit.

- 2. In order to facilitate the business community as a part of Ease of Doing Business, the Government of Punjab has initiated numerous steps including the introduction of Amnesty Scheme in payment of arrears of Social Security Contribution for the defaulter establishments by making amendments in Provincial Employees' Social Security Ordinance, 1965.
- 3. According to said amendment considerable relief has been given to the employers by addition of 3rd proviso to Section 23 (1). Owing to this proviso, if employer pays his unpaid contribution (Principal Amount) till 30.06.2021, statutory increase @ 50% of the principal amount under section 23(1) of the Ordinance booked against the unpaid contribution shall stand waived off. However, if such amnesty is not availed by the employer till 30.06.2021, the employer will be liable to pay principal amount as well as 50% increase booked on such unpaid contribution.
- 4. It is, therefore, requested to induce all your members to get benefit from the Amnesty Scheme before the time runs out and clear their dues (principal amount) at the earliest. The relevant material/ pamphlets have already been provided by this office.
- Co-operation in the matter would be highly appreciated, please.
