
Conclusively, Election Commission holds the decision under prevailing Rules and Regulations of the Election Process and hereby disqualifies your nomination for the election process 2021.

Your nomination was received and thoroughly discussed by the election commission in purview of the Trade Organizations Rules 2013 Ministry of Commerce, Government of Pakistan.

Your nomination paper was received on 30<sup>th</sup> August, 2021 as per Serial No.11 of the Election Schedule and was scrutinized as per Trade Rules 2013.
