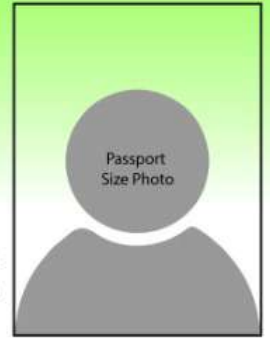

- ▶ In case of Partnership/AOP any of the partners may be nominated to represent.
- ▶ In case of Private Limited & Limited concerns, Chief Executive, Managing Director, General Manager or Company Secretary of the company may be nominated with the approval of the Board of Directors.

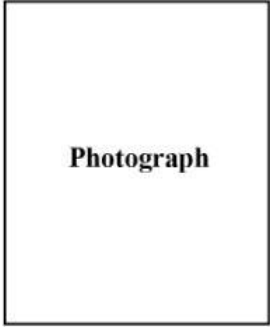
